The state provides focused and individualized technical assistance to districts for both the planning process and the strategic use of RLIS funds through its Federal Programs and Oversight (FPO) monitoring team. A team of four divisional coordinators works directly with districts to develop RLIS budgets, identify evidence-based solutions, coordinate the use of federal, state and local funds, and align the use of funds to identified needs. Divisional coordinators provide districts with written RLIS statutes, non-regulatory guidance, budget and planning guidance, templates, rubrics, training, and other supports as necessary to assist in understanding the allowable use of funds, RLIS eligibility, program requirements, and effective use of funds.
